If connected to the system and using water the monthly rate shall be based on the gallons used as stated in the Water Rate Schedule.

Tenant(s) agrees to pay to the County a minimum amount of One-hundred Dollars (\$100.00) as a water deposit. This deposit may be returned upon discontinuance of service without interest as provided by said Water and Sewer District Ordinance of the Public Utilities Division. The deposit shall be due prior to the County setting a meter for water usage.

Tenant(s) agrees to abide by the Water and Sewer Ordinance of the Public Utilities Division as approved by the Cumberland County Board of Commissioners, and further agrees to abide by such other Cumberland County ordinances, rules and regulations with respect to water service connections, as are adopted by the Cumberland County Board of Commissioners.

**I understand that executing the Tenant Water User Agreement is a binding contract, and that I will be billed monthly, even if I am not connected and have no water usage. I guarantee prompt payment of all utility bills for the service address printed above. I agree to remain responsible for utility bills for this service address from the date service is started until the day service is terminated at my request. I agree to be fully liable for all amounts due, including attorney's fees and all other cost of collections. The County reserves the right to terminate services in the event of non-payment.**
