



ACTION: Linda Devore moved that the Board certify the machines as presented. It was seconded and unanimously approved.

Vicki Hilburn presented the absentee report: 2 civilian absentee, 53 one stop voters from the last meeting.


ACTION: Irene Grimes moved that the Board approve the absentees as presented. It was seconded and unanimously approved.



ADJOURNMENT: There being no further business, the meeting was adjourned at 5:14PM.


