Cumberland County Board of Elections Election Day Meeting Oct 7, 2025

The Monthly Board Meeting was called to order by Chair Devore at 3:00PM.

ACTION:

Member Grimes made the motion to approve the agenda. The motion was seconded by Edmonds and approved unanimously.

Chair Devore opened up discussion of preliminary ballot challenges. Tasha presented a voter challenge for Shaquille Fredrick Miller that was a same day voter registration who appears to be a felon currently on active probation.

ACTION:
