1. Schedule . The schedule has been amended as follows:

11. Section 3.3 Site Analysis / 3.3.1 states: "The Project Manager will evaluate and recommend three potential locations for the proposed aquatics center. Reconcile schedule for punch list items, final inspections, and Owner move-in and start up." **This information is a general schedule for the feasibility study.**
12. We are preparing our response to the Aquatic Center RFP and wanted to ask whether participation on the consulting team for this planning phase would preclude or exclude team members from being eligible for any future design work on the project? **No, it would not preclude you from future design work.**
13. Is there a budget in mind for phase / feasibility study? **Not currently.**
14. Is there a target budget for the final facility? **This will need to be developed based on the study.**
15. 3.7.2 What is required for Full FF&E Coordination Services? **No.**
16. 5.5 Is a complete fee proposal required? **Yes** If fee proposal is required, is it to be submitted in a separate envelope/PDF? **No.**
17. Does the County have a known source of funding to support the construction and ongoing operating costs of the aquatic center? **No, this will have to be planned through our budget process. We would evaluate our funding needs based on the potential partnerships (Other local govt. partners, or a public /private partnership.** Or is the County looking for the consultant team to identify a range of potential funding sources and public/private partnership opportunities to support project delivery and operations/maintenance? **Not at this time, but if included in your RFP, we would consider adding as the feature of the potential contract if your firm is selected.**
18. Are you looking for a statistically valid survey? **Yes.**
19. Are you looking for the consultant to host a project website such as social pinpoint? **No but if recommended, we would consider.**
20. Can you define what is meant by "provide/project full FF&E coordination services" as stated on page 3 of the RFP? **This should not have been included in the RFP.**
