Introduction

Outreach

Our public health staff continue to offer services outside of our brick-and-mortar locations and during non-traditional hours to increase access to services.

To increase vaccination rates among school-aged students, staff partner with Cumberland County Schools to host four after-school on campus Back to School Vaccination clinics. Vaccines for respiratory viruses are also offered in the community in collaboration with other community-based organizations and outreach events. The health department received grant funds that allowed the WIC Division to hire an outreach coordinator to expand WIC outreach to military families. In partnership with local colleges and universities, staff in the STD clinic expanded outreach testing to young adults. The Connected Care program offered the first resource fair at Spring Lake Family Resource Center with more than 25 vendors to provide information and services to the public. Monthly, public health staff participate in the Cumberland County EMS Outreach Event to provide services to the unhoused population.

Community Engagement

Public health staff in collaboration with Cape Fear Valley Health System (CFVHS) began data collection for the 2024 Community Health Needs Assessment. Staff conducted a community survey and facilitated four focus groups identify the community's health status, needs, and resources. Community stakeholders convened to review the results and selected the following priorities: Behavioral health, to include mental health and substance use; physical health; and maternal and infant health. The final report is expected to be released in spring 2025.

In addition, public health staff conducted community meetings and a community survey to get feedback about the future use of Opioid Settlement Funds (OSF). Community members also had the opportunity to learn about the first two years of programs and services supported by the OSF. The feedback resulted in nine recommendations (\$3.2 million in OSF) approved by the county commissioners to be implemented in 2025-2029.

Public health staff provide administrative support to several community coalitions that were re-launched after COVID-19 including the Breastfeeding Coalition, Teen Wellness Taskforce, and the Perinatal Taskforce, which is a subcommittee of the Cumberland-Fayetteville Opioid Response Team (C-FORT). Meetings are open to the public and we invite anyone interested to attend to stay engaged with activities address the opioid crisis in our community.

Healthy Conversations

Healthy Conversations launched in 2023 as community-focused program designed to promote health awareness and education on topics including heart health, prostate cancer, and colorectal cancer. A public health educator trained 10 local barbers who advocated for health and wellness in their community. The barbers held more than 1,300 brief but meaningful conversations with their clients while they were getting a hair cut to support them in taking action to improve their health. In 2025, the cohort of barbers will expand to 20 barbers and stylists. The cohort will expand their conversations with clients to include mental health and substance use, including information on how to use naloxone.

Maternal Health Outcomes

There are wide differences in maternal deaths in the U.S. and specifically for racial and ethnic minorities. Increasing understanding urgent maternal warning signs and symptoms during pregnancy and in the year after delivery can help improve maternal health outcomes. A digital and print media campaign was launched to educate pregnant individuals, partners, and providers about these signs to seek medical care. Cumberland County co-hosted the 2nd OB-GYN conference and three post-conference workshops in collaboration with Southern Regional Area Health Education Center and CFVHS. More than 80 individuals attended the conference to strengthen the system of care for obstetrical and gynecological (OB/GYN) patients and aim to decrease maternal mortality with a focus on disparities. Birth doula care is one strategy that can help improve health outcomes for the birthing person and baby. In the fall, a request for proposals was released to support doula services. Implementation of doula services for the two awarded agencies is expected to begin in 2025.

Opioid Response

The Cumberland-Fayetteville Opioid Response Team (C-FORT) continued its efforts to have a well-coordinated and strategic response to opioid crisis. Between 2023-2025, federal funding supported more than 120 unique individuals in receiving transitional housing. In addition, nine individuals were trained as peer support specialist and 30 were trained as SMART Recovery Facilitators resulting in seven new SMART Recovery groups.

In October, the C-FORT Recovery Resource Center opened as a resource hub for individuals impacted by substance use and seeking recovery support services. The Center is made possible with Opioid Settlement Funds and supported by community partners who offer trainings, classes, recovery groups, and peer support specialist services.

In 2025, the health department and C-FORT partners will begin implementation of two federal grants that will expand access to naloxone training and distribution, enhance the Law Enforcement Assisted Diversion (LEAD) program and improve coordination of services for those involved with the criminal justice system.

Awards

The CCDPH Baby Store won the NC GlaxoSmithKline Foundation Child Health Recognition Award at the 2024 North Carolina Public Health Association Fall Educational Conference. The Baby Store is an incentive-based, health promotion program that aims to support healthy moms and healthy babies. The Baby Store encourages new and current clients to schedule and keep their child and maternal health appointments. Health Department clients earn "baby bucks" by attending their appointments. Once "baby bucks" are earned, they can be used at the Baby Store to purchase items such as diapers, baby wipes, clothing, car seats, sleep sacks, pack and plays and more. A health educator is available to assist the client with education and training. In 2023, there were 897 Baby Store appointments served. At the time of the award, the health department was on track to exceed the number of Baby Store appointments with 639 appointments completed by the end of June 2024. The Baby Store opened in 2010 and since then has become a staple of receiving health department services. The Baby Store was initially made possible through grants awarded by the March of Dimes and the North Carolina Office of Rural Health. Once grant funded ended, health department staff advocated to utilize county funds to enhance and continue the operation of the Baby Store. Due to the success and impact of the Baby Store, county funds have supported the Baby Store since 2021.

Cumberland County has earned Excellence in Innovation awards from the North Carolina Association of County Commissioners for the Ft. Liberty Public Health Partnership and the WIC office opening on Ft. Bragg. The Health Department has worked diligently with this collaborative group between Cumberland County Department of Public Health, Fort Bragg Department of Public Health, and UNC Chapel Hill. Opening the new location is offering a culturally responsive option to addressing food insecurity amongst military families and allows for innovative approaches to messaging on nutrition and healthy eating. Additionally, the collaboration between these partners has afforded the group to present best practices for opening a WIC office on a military installation across professional conference networks and via the Military WIC Office Council (MWOC), a monthly forum for information sharing regarding WIC and military populations.

Accreditation

The North Carolina Local Health Department (NCLHD) Accreditation Program seeks to assure and enhance the quality of local public health in North Carolina by promoting the implementation of activities for local public health departments and evaluating and accrediting local health departments on their ability to meet these activities. The program is based on the three core functions of assessment, assurance and policy development and the ten essential services as detailed in the National Public Health Performance Standards Program.

Accreditation Team

To meet the requirements of accreditation, Cumberland County Department of Public Health developed an accreditation team which currently consists of 21 staff members who worked collaboratively to collect, review, organize and upload evidence to support 41 benchmarks (147 activities).

In May 2023, CCDPH learned the exciting news that they were reaccredited with honors, an accreditation status for health departments that miss one or fewer activities within each standard. In 2024 the team has worked hard to meet the requirements of annual evidence. Their next site visit will take place in Winter 2027.

Tobacco Control Program

The Tobacco Control and Prevention Branch in Cumberland County remains committed to leveraging allocated funding from the TPCB of the North Carolina Division of Public Health (NCDPH). Region 6 has also received funding from a lawsuit involving Juul tobacco products. Cumberland Region 6 encompasses 10 counties: Cumberland, Hoke, Harnett, Lee, Moore, Montgomery, Randolph, Richmond, Anson, and Scotland.

Beyond our efforts spanning these 10 counties, Cumberland County collaborates closely with the Fort Liberty Department of Public Health, the UNC Lineberger Comprehensive Cancer Center, and Duke University Center for Smoking Cessation. Together, we are actively engaged in a Military Health Readiness Initiative and QI projects, addressing tobacco use and fostering health systems changes on the installation. This collaborative approach underscores our dedication to enhancing the overall health and well-being of our community.



Connected Care Program

The Connected Care Program was launched in 2023 as a joint program between the Cumberland County Department of Social Services and the Department of Public Health. The goal of the program is to improve overall health outcomes and quality of life for residents in Cumberland County. Connected Care Program assists individuals and families of all ages. In 2024, Connected Care Program received 250 referrals and worked with 240 families and individuals. Additionally, Connected Care Program staff have attended numerous outreach events to address health issues, food and housing insecurity, unmet social and emotional needs, and unemployment. The Connected Care Program receives referrals from community partners and organizations through



NCCARE 360, walk-ins, outreach events, by phone, and through our email address. The Connected Care Program team consists of an Administrative Officer II, a Social Work Supervisor II, Social Workers, Health Educators, a Nutritionist, a Nurse and one Income Maintenance Caseworker and a Community Social Services Assistant. Connected Care Program connects individuals and families to available resources to address their needs. Healing from Within

The Healing from Within program, implemented at the Cumberland County Detention Center (CCDC), offers Medication-Assisted Treatment (MAT) and connects detainees with community resources. This collaborative initiative involves the Cumberland County Detention Center, Wellpath, and the Public Health Department. The MAT program provides FDA-approved medications to individuals with substance use disorder, to minimize the risk of post release overdose, death, and recidivism. During incarceration, detainees receive counseling, resources, and connections to external agencies for a seamless transition upon release. Additionally, our LCSW and CCDC Peer Support Specialist works closely with Veteran and Family Drug Courts to ensure comprehensive support.

Women's Preventive Health Services

The Women's health clinic includes the maternity clinic which offers complete low risk prenatal care and delivery services for any pregnant Cumberland County resident. Services include: physical exams, laboratory testing and prenatal healthy lifestyle education. The family planning clinic serves women of child-bearing age desiring to plan and space births by providing contraceptives and preconception counseling. The breast and cervical cancer program (BCCCP) focuses on low-income women 40-64 years of age. Women enrolled in the program receive a pap smear and mammogram screening, and the necessary follow-up on any abnormal results. The pregnancy test counseling section offers confidential services for adolescents and adults who are seeking confirmation of their pregnancy status.



Pharmacy

The Cumberland County Medication Access Program (CCMAP). Is dedicated to improving the quality of life for eligible residents by operating a licensed, non-profit pharmacy that assist patients with obtaining medication for chronic disease.

Since opening, CCMAP had dispensed 480,998 prescriptions with a value of \$156 million (AWP).

Medical/Vital Records

The Medical Records Division is responsible for managing patient records, ensuring they are scanned into a document management system. This system makes the records accessible to clinical staff, providers, and patients upon request. The division is also tasked with compliance with the Health Information Portability and Accountability Act (HIPAA), and the division's manager serves as the HIPAA Officer. This officer ensures that all public health employees and representatives receive training on HIPAA confidentiality and security and that policies and the Notice of Privacy Practices are maintained and up to date.

Vital Records, on the other hand, handles the records of births and deaths in Cumberland County using the NCDAVE System. The deputy registrar processes the burial transit permits, follows up with doctors and medical examiners for the completion of death certificates, supports parents by assisting with Affidavits of Parentage (AOPs) home births, and maintaining vital statistics data.
