#### Item 1. Call to Order:

Martina Sconiers Talbert welcomed everyone and called the meeting to order.

Due to the absence of many members *Beth Maynard* and *Shannon Gettings* agreed to adjust the November agenda for the night and skip the approval of October meeting meetings.







#### **Item 2. Items for Discussion**

a. Food Insecurity Saturday Event Update

Anne Smiley provided an overview of the structure for the upcoming community event focused on food insecurity. The event will include a light breakfast, a guest speaker from Bread for the World, and three rotating tabletop sessions led by local organizations. Scribes will document participant stories for later transcription and submission to legislators along with advocacy postcards.

Confirmed or pending participating organizations include Public Health, DSS, Cumberland County Schools, WIC, Bread for the World, and local food pantries. The council discussed the importance of securing representation from military families. Event marketing includes flyer distribution, media outreach, social media posting, and notification of elected officials. *Roni Winston* will host an FPC information table.

- b. Board and Commission Orientation Update
  - *Martina Sconiers-Talbert*, shared with members that the county's upcoming orientation session is not required for the Food Policy Council at this time. Members will be invited to the next session following appointment cycles in early 2026. The council will continue using its internal orientation process for new members.
- c. Legislative Updates SNAP, WIC, and Child Nutrition Programs
   *Tamra Morris* provided an update on WIC and SNAP benefits.
   WIC: Funding has been secured through the month of November, allowing all local sites to operate at full capacity. Redemption levels remain slightly elevated but stable.
  - ---SNAP: USDA issued a temporary pause on November benefits due to the federal shutdown. Clarification is pending regarding potential partial distribution. DSS remains fully operational and continues to serve over 33,000 households.
  - ---Child Nutrition Programs: School meal programs will continue through January using advance USDA funding and existing district reserves.
- **d.** Proposed Legislative Priorities for 2026
  - *Tamra Morris* presented recommended legislative priorities including full funding for major federal nutrition programs, restored SNAP funding, and full funding for WIC expansion efforts. Members requested a draft be posted to Basecamp for review. Additional discussion included creating a standalone priority focused on supporting local farmers.

   Beth Maynard shared updates regarding school meal funding and noted that USDA has advanced funding allowing operations through January. Cumberland County received 18
