The Cumberland County Board of Commissioners will hold a public hearing on Monday, November 17, 2025, beginning at 6:45 P.M. or shortly thereafter, in the County Commissioners' meeting Room 118, on the first floor of the Judge E. Maurice Braswell Cumberland County Courthouse, located at 117 Dick Street in Fayetteville, NC and will hear the following:

ZON-25-0037: Rezoning request from A1 Agricultural RR Rural Residential, PND Planned Neighborhood District, and CD Conservancy Districts to A1 Agricultural District or to a more restrictive zoning district for six parcels comprising 725.88 +/- acres; located north of the Cape Fear River, along the north and south sides of McBride St and Slocomb Rd, and approximately three-quarters of a mile west of Lane Road; submitted by J. Scott Flowers (Agent) on behalf of McCormick Farms Limited Partnership (Owner).

A sketch map identifying the location of the above referenced property, shown in a cross-hatched pattern, appears on the reverse side of this letter.


