



Ad Valorem Tax Rates Per \$100 Valuation

For Cumberland County and its Municipalities for 2016 Year Tax Bills (FY17)

1. Property taxes become due each year on **September 1st** and must be paid by **January 5th** to avoid interest, penalties, and/or collection proceedings.
2. Go to www.co.cumberland.nc.us and click on "Pay Taxes Online" to pay your taxes by using your credit/ debit card or electronic draft, or call (910) 678-7507 to set up [payment arrangements](#).
3. These tax rates and fees also apply to all newly registered and annually renewed **motor vehicles** on the NC combined vehicle registration renewal and property tax notice received from the NC DMV. Please pay the combined registration and tax notice to the NC DMV at any DMV license plate agency, by mail, or online at www.ncdot.gov/dmv under the link 'renew your registration'. ** See NOTE.

| Bona Fide Seeing Eye or Aid Dog | No cost; must apply for permanent license |
| Residents 65 or older | No cost for up to 3 Dogs/Cats per residence |
| For each STERILIZED Dog/Cat/Ferret | \$7 annually |
| For each UNSTERILIZED Dog/Cat/Ferret | \$25 annually |
| For Hunters – 5 to 15 Dogs | \$100 annually |
| For Hunters – 16 Dogs or more | \$150 annually |
| For Dog/Cat/Ferret Breeders | \$50 annually per breeding pair of Dogs/Cats/Ferrets |

The motor vehicle privilege tax and transit fees are applicable to every registered motor vehicle, and defined in NCGS 20-4.01(49) as "Every device, in, upon, or which any person or property is or may be transported or drawn upon a highway..."; such as: automobiles, motorcycles, travel and utility trailers, trucks, and recreational vehicles.

**** NOTE:** Active Duty, **NON-RESIDENT** military personnel who have been exempted from paying the ad valorem property taxes on motor vehicles are also exempt from the motor vehicle privilege tax and transit fees.
