## County 911 Center Receives Medical Dispatch Accreditation

FAYETTEVILLE – Cumberland County’s 911 Communications Center has been designated as an Accredited Center of Excellence for emergency medical dispatch by the International Academies of Emergency Dispatch.

Emergency Services Director Randy Beeman was notified Monday evening that the center had achieved the accreditation. The IAED website states that “Accredited Centers share a common goal of improving public care and maximizing the efficiency of 911 systems.”

The County will receive a plaque later and is accredited through 2020.

“I am very proud of the communications center staff. They deserve all the credit for their hard work and dedication. This acknowledges that our center is meeting national standards and providing the highest level of service to the citizens,” Beeman said.

The County’s center has 40 employees and handles more than 19,000 medical dispatch calls annually.

The County’s 911 Center is poised to migrate to the next level of technology, known as “Next Generation 911,” in the spring when it moves to EsiNet, a statewide project that will link call centers in North Carolina through the AT&T EsiNet system. The N.C. 911 Board, on behalf of the state, has contracted with AT&T to carry out the project.

“We believe the center’s ability to move swiftly to this next level of optimal operating capacity is in the best interest of our citizens,” Beeman said.

#### **BACKGROUND**

##### **Emergency Telephone Fund 260**

##### **1. Emergency Telephone System - Budget Ordinance Amendment B180764 in the amount of \$24,426 to upgrade recording equipment**

The Board is requested to approve Budget Ordinance Amendment B180764 in the amount of \$24,426. These funds will be used to upgrade equipment to allow recordings for both voice and text messages. These funds are fully reimbursable by 911 and have been approved by the 911 Board.

Please note this amendment requires the use of Emergency Telephone Fund Balance.

#### **REGARDING ITEM 2 PLEASE NOTE:**

Each fiscal year County departments may have projects that are not complete by the fiscal year end (6/30/17) or items ordered that have not been received by fiscal year end. These projects or items were approved in the Fiscal Year 2017 budget; however, the money was not spent by June 30, 2017.

The following amendments seek to bring those funds forward from FY 2017 into the current fiscal year, allowing departments to complete and pay for these items. These revisions are not using 'new' funds, but are recognizing the use of FY17 funds in FY18.

##### **General Fund 101**

**2. Sheriff's Office - Budget Ordinance Amendment B180864 to bring FY17 funds forward in the amount of \$2,794 towards repairs to a vehicle.**

The Board is requested to approve Budget Ordinance Amendment B180864 to bring FY17 funds forward in the amount of \$2,794. A Humvee was damaged during Hurricane Matthew however, the insurance settlement was received late in FY17. This request is to move those funds forward so that the necessary repairs can be made to the vehicle.
