Approval of Report on Delinquent Real Property Taxes for the Year 2016

BACKGROUND: North Carolina General Statute 105-369 requires the Tax Administrator to report unpaid taxes for the current fiscal year that are liens on real property by the first Monday in February. The purpose of the reporting is to allow you to order the Tax Administrator to advertise the tax liens. Upon receipt of your order, I will advertise the tax liens by posting notice at the County Courthouse and by publishing each lien at least one time in one or more of the newspapers having general circulation in Cumberland County.

The statute requires the advertisement period for unpaid taxes that are liens on real property to occur during the period of March 1st through June 30th. It is my intention to deliver a list of delinquent taxes to the Fayetteville Observer newspaper prior to June 30th for advertisement.

Total delinquent taxes on real property for Year 2016 as of 1/27/17:

\$12,925,082 on 15,670 parcels

RECOMMENDATION: Accept the report of unpaid taxes for the current fiscal year that are liens on real property and charge the Tax Administrator to advertise a list of the tax liens on real property by posting notice at the County Courthouse and by publishing each lien at least one time in the Fayetteville Observer no later than the month of June 2017.

BACKGROUND

In accordance with North Carolina General Statute 18B-805(h), Expenditure of Alcoholism Funds: Funds distributed under subdivisions (b)(4) and (c)(3) of this section shall be spent for the treatment of alcoholism or substance abuse or for research or education on alcohol or substance abuse. The minutes of the board of county commissioners or local board spending funds allocated under this subsection shall describe the activity for which the funds are to be spent. Any agency or person receiving funds from the county commissioners or local board under this subsection shall submit an annual report to the board of county commissioners or local board from which funds were received, describing how the funds were spent.

For fiscal year 2016 collections related to (b)(4) totaled \$102,311; collections related to (c)(3) totaled \$216,189; for a combined total of \$318,500. To be in compliance with this statute, Alliance Behavioral Healthcare has reported that provider agency Carolina Outreach provided substance abuse services totaling \$535,541 and served 387 substance abuse consumers over the course of fiscal year 2016.

RESOLUTION SEEKING RELIEF FROM THE INCREASE TO CERTAIN PROPERTY TAX HOMESTEAD EXCLUSIONS PROPOSED IN 2017 H.B. 2

Whereas, G.S. 105-277.1C provides a property tax homestead exclusion for the first \$45,000 of appraised value of a home owned and occupied by a disabled veteran or the veteran's surviving spouse; and

Whereas, Cumberland County currently has 3,799 residents receiving this homestead exclusion and the number of these exclusions has historically increased each year; and

Whereas, after deducting the current exclusion amount of \$45,000, the 2016 assessed tax value of properties subject to this exclusion was \$374,036,884; and

Whereas, at the 2016 county general tax rate, the county property tax on this property was almost \$2,770,000; and

Whereas, this does not include the separate property tax levied by any municipality, fire district or recreation district in which the properties are located; and

Whereas, 2017 House Bill 2 proposes to add additional classifications of property subject to this homestead exclusion and to increase the homestead exclusion amount from \$45,000 to 100% of the appraised value; and

Whereas, increasing the homestead exclusion amount to 100% of the appraised value of the currently eligible properties alone will result in the loss of \$2.77 million in property tax revenue to the county's General Fund, and additional losses in property tax revenue to the municipalities and special tax districts in which these properties are located; and

Whereas, from its General Fund, Cumberland County funds Veterans Services as a county department which provides a broad range of services for all veterans.

Now therefore be it resolved, that the Cumberland County Board of Commissioners requests the General Assembly to include a provision in 2017 House Bill 2 to hold all taxing jurisdictions harmless for the loss of property tax revenues resulting from the proposed increase of the homestead exclusions.

Whereas, through statutory changes in the last five years, the General Assembly has shifted responsibility for the provision of mental health services from county programs and multiple area authorities to consolidated regional Managed Care Organizations serving large regions of the State consisting of many counties; and

Whereas, this regional consolidation of the management of the provision of services is expected to continue, resulting in fewer and larger regional Managed Care Organizations; and

Whereas, though this regional consolidation has greatly diminished the means by which counties could formerly direct the level and nature of mental health services provided within their respective communities, the statutory mandated level of county funding for the provision of these services remains as it was when the services were provided by county programs and single-county area authorities more than 30 years ago; and

Whereas, affording counties flexibility for funding mental health services will place counties in a better position to negotiate contracts with their respective Managed Care Organizations to enhance the efficient provision of services tailored to local needs.

Now therefore be it resolved, that the Cumberland County Board of Commissioners requests the General Assembly to give counties discretionary authority to fund local mental health services by amending G.S. 122C-115(b) by deleting "shall" in the first sentence so that it reads, "Counties and cities may appropriate funds for the support of programs" and by further deleting subsection (d) in its entirety.

Whereas, affording county Boards of Elections the flexibility to determine the duration of the One Stop Voting period will enhance the efficiency of conducting modern elections, particularly in those counties where most voters vote before Election Day.

Now therefore be it resolved that the Cumberland County Board of Commissioners requests the General Assembly to amend G.S. 163-227.2(b) by providing that the county Board of Elections shall establish that the One Stop Voting period may begin no earlier than the third Thursday before an election and no later than the second Thursday before an election.

The attached presentation summarizes the draft report and includes important findings and recommendations that will be presented to the City of Fayetteville, Cumberland, Harnett and Hoke Counties during the month of February. The consultants encourage local elected officials to read the main body of the report, especially the analysis, impact models, and strategies. 
BACKGROUND:

Under the terms of the financing instruments the school board's consent is needed for this donation.

Also, a boundary plat of the right of way is attached but it appears only as a straight line because it is so narrow. 
