Chairman Kenneth Edge called the meeting to order.

PUBLIC COMMENT PERIOD (6:45 PM - 7:00 PM)

James Martin, County Manager, read the public comment period policy. Chairman Edge opened the public comment period and the Clerk to the Board called the following speakers:

Regina McLean – Ms. McLean thanked three staff members of the Planning and Inspections Department who she felt had helped clarify her situation. Ms. McLean stated over the past several months she felt she had been racially discriminated against regarding a piece of property she felt had not been inspected correctly. Ms. McLean further stated she was here tonight to remove any racial insinuations and deal with the issues because a lot of information had been left out earlier and mistakes had been made. Ms. McLean stated she felt a closed session was needed to correct the mistakes so she and her mother would not have to bear the burden.

Commissioner Melvin asked Ms. McLean whether it was fair to say he had listened to her and his main goal was to straighten out the issue, if it was fair to say she felt like she was still at a standstill, and if she agreed with saying stop in order to start over. Ms. McLean agreed.

Commissioner Melvin stated he had a plan which was for Ms. McLean, a county inspector and himself to visit the trailer and start over from scratch. Ms. McLean stated she would respond to the plan in writing. Commissioner Melvin stated he would listen to Ms. McLean should she have suggestions for revising his plan.

Weyher Dawson – Mr. Dawson provided a report card for Service Source and thanked the Board for its support of the nonprofit organization over the years. Mr. Dawson stated Service Source is aware the property it leases from the county is adjacent to property given to Fayetteville State University (FSU) as part of the Murchison Road initiative and Service Source has expressed to FSU its support for the public/private partnership initiative. Mr. Dawson further stated Service Source is operating under a one-year lease and asked the Board to consider a five-year lease. Mr. Dawson responded to questions.

BACKGROUND:

The Board has received a request from NCDOT to concur with its intent to abandon a portion of SR1826 Wade Stedman Road from the old intersection with NC Highway 13 to a point 265 feet south. According to a letter received from Mr. David Plummer, SR1826 has been realigned at the intersection with NC Highway 13 rendering a portion of the old SR1826 obsolete. The property owner, along said portion of SR1826 to be abandoned, has petitioned NCDOT to remove this section from the State's Secondary Road System. Once NCDOT takes this action, the property owner will likely petition the Board to permanently close the road in accordance with NCGS 153A-241. A resolution that concurs with NCDOT's intent to abandon said portion of SR1826 from the State's Secondary Road System will need to be approved.

RECOMMENDATION/PROPOSED ACTION:

The recommendation of the County Engineer, County Attorney and Management is to approve the resolution. The proposed action by the Board is to approve the staff recommendation.

- D. Approval of Report and Recommendation of the Cumberland County Facilities Committee:
 - 1. Approval of Construction Manager at Risk Agreement for County Detention Center Expansion Project

BACKGROUND:

The Board of Commissioners, at its September 6, 2011 meeting, approved Metcon-Balfour Beatty a joint venture, as the Construction Manager at Risk (CMaR) for the County Detention Center Expansion Project and authorized staff to begin contract negotiations. The County Engineer has taken the lead in the negotiations with assistance from Management and the County Attorney. The form of agreement for Construction Manager at Risk services for the Detention Center Expansion is essentially the same as used for the construction of the Public Health Center and include the AIA Document A121CMc "Standard Form of Agreement Between Owner and Construction Manager", AIA Document A201 "General Conditions" which are County edits to the AIA A201 document. The agreement has been reviewed by the County Attorney for legal sufficiency and is available for inspection in the County Attorney's Office.

Negotiation of fees for CMaR services is a two phase approach as follows:

The Pre-Construction Phase includes all services provided by the CMaR during the facility design through development of the Guaranteed Maximum Price (GMP). The scope of pre-construction services is indicated in Exhibit B of the agreement and is attached for reference. A stipulated sum of \$87,120.00 was negotiated for this phase. In addition, the CM fee is proposed at 3.40% of the direct General Conditions plus the subcontractor cost of work and the CM Contingency is proposed at 2.00% of the subcontractor cost of work. All unspent CM Contingency funds will be returned to the Owner. The GMP will be developed once subcontractor bids have been received, reviewed and accepted by the Owner. The GMP includes the CM General Conditions (direct cost of managing the construction project), Subcontractor cost of work, CM Contingency, CM Fee and the cost of bonds and insurance. Exhibit C of the agreement provides a detailed breakdown of the cost items that make up the GMP as is attached for reference. Exhibit A of the agreement is attached for reference and is a matrix of Project Cost Elements indicating the allocation of the various cost elements as either in the CM Fee, Lump Sum Pre-construction Fee, Lump Sum General Conditions, Reimbursable General Conditions, Subcontractor Cost of Work or Owner Costs.

The Construction Phase begins upon acceptance of the GMP and issuance of a Notice to Proceed by the County. This phase includes managing the construction project through completion and acceptance of the work and during the warranty period. An amendment to the CMaR Agreement will be required to include the negotiated and approved GMP.

This information was presented to the County Facilities Committee at its October 6, 2011 meeting for its consideration. The recommendation of Management and staff to approve the draft Construction Manager at Risk Agreement with Metcon-Balfour Beatty subject to review by the County Attorney for legal sufficiency was endorsed by the Facilities Committee.

Subsequent to the Facilities Committee meeting, the County Attorney has completed his review of the agreement for legal sufficiency.

RECOMMENDATION/PROPOSED ACTION:

The recommendation of the County Facilities Committee, County Engineer, Management and the County Attorney is to approve the Construction Manager at Risk Agreement with Metcon-Balfour Beatty, a Joint Venture, for the Detention Center Expansion Project. The proposed action by the Board is to follow the staff recommendation.

2. Approval of Design Development Plans for County Detention Center Expansion Project

BACKGROUND:

Mr. Doug Zawiskie with Moseley Architects presented the final Design Development plans for the County Detention Center Expansion Project to the County Facilities Committee at its October 6, 2011 meeting. The slides from the presentation are attached for reference. During the design development phase, additional refinements to the floor plans have been made, with approval from the Project Committee, to reduce square footage and enhance the functionality of the design. Upon approval of the Design Development plans, the next phase is to prepare the Construction Documents which include the construction plans and specifications which will be used by our Construction Manager at Risk to subdivide the work into trade packages and solicit bids from pre-qualified subcontractors. The architect plans to have the Construction Documents Phase completed by the end of the year.

The Facilities Committee endorsed the recommendation of the Project Committee and Management to approve the Design Development plans.

RECOMMENDATION/PROPOSED ACTION:

The recommendation of the County Facilities Committee, the Project Committee and Management is to approve the Design Development plans for the County Detention Center Expansion and instruct Moseley Architects to submit the Design Development Package to the State regulatory agencies for review and comment. The proposed action by the Board is to follow the staff recommendation.

Ms. Cannon further explained the funds were actually received in a prior fiscal year so it was not general fund balance but fund balance created by the receipt of federal forfeiture funds. Commissioner Faircloth asked what constituted the expenditures. Ms. Cannon stated upcoming renovations of the Law Enforcement Center would include interview rooms with miscellaneous furniture and equipment as well as \$47,000 for a bond technician. Ms. Cannon also stated she would provide additional detailed information should the Board so desire.

3. Presentation by Dr. Larry Keen, President, Fayetteville Technical Community College and Mr. Chip Lucas, Executive Director, Career and Technical Education, Cumberland County School System on Career and Technical Education Program Update

BACKGROUND:

One of the five goals of the 2011-2012 Cumberland County Strategic Plan is to ensure a safe and healthy community by providing needed services to our citizens in a timely manner. An objective under that goal is to assist with reducing youth crimes and gang involvement by providing youth development program opportunities. One action step for that objective calls for the County Commissioners to advocate for alternatives to the high school academic track and to see an increased focus on vocational and military programs to combat the drop-out rate.

At the request of the Policy Committee, County Manager James Martin invited Dr. Larry Keen, President of Fayetteville Technical Community College (FTCC), and Dr. Frank Till, Superintendent of Cumberland County Schools, to report to the full Board of Commissioners on retention and vocational educational opportunities for high school students currently being offered through the public school system and FTCC and any plans to expand such programs in the future.

RECOMMENDATION/PROPOSED ACTION:

Chairman Edge welcomed Dr. Larry Keen, Fayetteville Technical Community College President. Dr. Keen provided the following report of retention and vocational educational opportunities currently being offered for high school students through FTCC's close working relationship with the Cumberland County School System.

Dr. Keen explained the drop in enrollment in the fall of 2011 was due to a change in state legislation and the fact that some of the schools decided to only send their senior students whereas in the past FTCC had been able to accommodate juniors and even some sophomores.

Dr. Keen explained the lack of enrollment in automotive fabrication repair in the fall of 2011 was due to the fact that students did not want to commit to the two-year program which resulted in the program being pulled altogether. Dr. Keen further explained the school system's

ServeSafe Program offset the Demi-Chef program and reduced the fall 2011 enrollment in that program.

Academy Completers

Dr. Keen stated everyone needs to do a better job in tracking students to find out exactly where they go following completion of the academy to ensure they stay engaged and stimulated to remain in school.

Dr. Keen stated when it comes to the program for game design, today's young people are not only talented, but are also creative and innovative. Dr. Keen further stated students completing the CNA program receive extra points towards their application to the nursing program.

Career and College Promise

Beginning January 2012, Governor's program for high school students with three pathways:

• Cooperative innovative high school programs

- Career technical education pathways
- College transfer pathway

With regard to the career technical education pathways, Dr. Keen stated this program is for young people who are capable of learning but sometimes learn in less typical ways. Dr. Keen expressed concern that the 2.0 or 2.5 that was felt to best accommodate the needs of these young people was bumped back up to 3.

Career and College Promise Pros

- Structured pathways provide a certificate, diploma, or degree with entry-level job skills
- High school students can graduate with a community college certificate
- Fees and textbooks will be paid by the Local School Administrative Unit (LSAU) or student
- College Transfer certificates are being created

Dr. Keen explained students function better with structured pathways that support the kinds of opportunities, behaviors and skill sets that increase the likelihood of their succeeding and being stimulated to seek additional education.

Career and College Promise Cons

- Admission criteria into the program are strict.
- High GPAs and placement scores are required.
- High school freshmen and sophomores are eliminated from participation.
- Students must follow structured programs.
- Program is subject to state legislative changes, cuts, and mandates.

Dr. Keen stated the most frustrating and challenging thing about this program is when legislation changes, it is like starting the program all over again.

Expansion for 2012 - 2013

Beginning 2012-2013, Career and College Program offerings will include the following expanded areas of study:

- Basic Collision Repair and Refinishing Technology
- Basic Plumbing
- Machining Technology/Basic Computer-Integrated Machining
- College Transfer

Dr. Keen stated young people engaged in these expanded areas of study can get their hands and minds involved in something that is meaningful and then go to work. Dr. Keen further stated these areas of study not only provide opportunities for students to go to work for existing companies but also provide opportunities for them to start their own businesses after having gained some experience.

Dr. Keen stated FTCC was selected as to participate in the advanced integrated manufacturing program ordered by the Department of Labor and will receive funds in the next three years to

ensure the program helps advance manufacturers so the competitiveness in the area will be much greater for not only keeping, but attracting these industries.

FTCC and Cumberland County Schools will collaborate in developing additional certificate options. Programs will be created in areas that include but are not limited to the following:

- Business
- Computer Information Systems
- Criminal Justice
- Education
- Horticulture

Dr. Keen concluded his presentation by stating this year marks FTCC's 50th year of service to Cumberland County and thanked the Board of Commissioners for their continued support. Dr. Keen responded to questions.

Chairman Edge called Chip Lucas, Cumberland County Schools Career and Technical Education Executive Director, who recognized Allison Violette, Cumberland County Schools Associate Superintendent. Mr. Lucas provided an update on career and technical education program areas offered by the Cumberland County Schools.

Mr. Lucas stated the career and technical education programs are for the secondary schools 6th through 12th grades and serve as precursors to the community college technical education programs. Mr. Lucas explained there is a duplicated count because the exploratory courses in the middle schools branch out into eight different program areas in the high schools. Mr. Lucas noted there are thirty-one secondary schools in Cumberland County.

Mr. Lucas explained CTE graduates have four credits in a career and technical education program when they graduate from high school and the percentages as shown demonstrate that career and technical education programs keep students in school and graduate them.

Mr. Lucas stated the school system's curriculum for the career academies serves as the foundation for the community college's career programs; academies include agriculture and natural sciences where students in these enhanced programs learn about environmental and natural resources as well as biotechnology. Mr. Lucas also stated the emergency medical service academy is new and emerging, and the engineering technology program uses a pre-engineering program so students can learn about robotics. Mr. Lucas stated the finance academy is the oldest of the career academies and students learn about banking and finance; the health science and technology academy is most investigative in nature.

Mr. Lucas pointed out that the student engagement involved in the academy programs fosters a sense of belonging and a smaller learning environment which makes the students feel they are well on their way to graduating.

Mr. Lucas stated the emergency medical services academy at Pine Forest is working closely with fire fighters at the newly proposed fire station on Andrews Road. Mr. Lucas explained there are two academies of information technology located at opposite ends of the county; students engaged in foundations of information technology as well as some of the programs at FTCC learn about hardware, software, networking and security concepts; students in the applied engineering program learn more about pneumatics and robotics. Mr. Lucas stated green technology provides students an opportunity to learn about solar, wind, sustainability and emerging technology. Mr. Lucas explained various partners within the community include the military, DuPont, and other businesses and industries which provide students with internships, engagement opportunities, job shadowing, exploration, and learning on the job that helps them decide what to pursue as their post secondary areas of learning or as careers for the future.

Program Areas

Agriculture Education Business, Finance and Information Technology Career Development Family and Consumer Sciences Health Science Education Marketing and Entrepreneurship Education Technology Engineering and Design Education Trade and Industrial Education

Mr. Lucas stated the program areas as outlined are available in most high schools. Mr. Lucas explained although agriculture is still learning about horticulture and landscape, it also focuses on biotechnology, animal science, and other new areas. Mr. Lucas stated students of business and finance have an opportunity to learn not only business law, principals of business and finance, but also the latest Microsoft software and are given the opportunity to earn industryrecognized certifications and credentials. Mr. Lucas explained the career development program area is exploratory and allows students to learn about various types of careers; family and consumer sciences is what was formerly known as home economics and covers early childhood education, apparel development, foods/nutrition/culinary arts, and the ServeSafe program. Mr. Lucas stated students are prepared to earn the certified nursing aid credential under the health science education program area and if they pursue the four credit sequence, they can sit for the certified nursing assistant exam. Mr. Lucas explained the marketing and entrepreneurship education program enables students to learn about small business information, entrepreneurships, and sports marketing; the technology engineering and design program enables students to learn about pre-engineering concepts, principles of technology, and applied physics using a hands-on concept.

Trade and Industrial Areas

Automotive Technology Cabinetmaking Carpentry Collision Repair Criminal Justice Drafting TV Programming and Broadcasting

Mr. Lucas explained trade and industrial education includes one carpentry program, one cabinet-making program, and one collision repair program; criminal justice and drafting are offered at all high schools throughout the county; and TV programming and broadcasting is offered at one high school. Mr. Lucas stated FTCC will bus students to their campus for some of these programs because of the associated high costs and space requirements that the school system can not meet.

Mr. Lucas explained each of the program areas has a career and technical student organization that promotes a sense of belonging and helps to develop leadership skills.

Partnerships

Mr. Lucas stated the Cumberland County Schools engage speakers from the community to talk about career programs; entrepreneurship conferences are provided through FTCC, FSU and Methodist College centers for entrepreneurship. In closing, Mr. Lucas stated Cumberland County School's career and technical education programs would not be what they are without the strong partnerships with the post secondary institutions. Questions and comments followed.

Chairman Edge recognized Greg West with the Board of Education and stated the Board of Commissioners appreciates all that the Cumberland County Schools and FTCC are doing and shares their concerns with the drop out rate. Chairman Edge further stated each student that graduates with a high school diploma reduces the services the county may otherwise have to provide for them.

4. Presentation by Mark Culbreth from the Cumberland County School System on the Reading Rocks Program

BACKGROUND: Mark Culbreth of the Cumberland County School System will be attending the October 17, 2011 Board of Commissioners meeting to make a presentation on the "Exceptional 8th Year" Reading Rocks! Walk-a-thon which is scheduled for Saturday, October 22, 2011.

Mr. Culbreth extended an invitation on behalf of over 54,000 Cumberland County School students, the Board of Education, Dr. Frank Till, and staff of the Cumberland County Schools to the Board of Commissioners to be their guests at the Reading Rocks Walk-a-thon. Mr. Culbreth stated the walk-a-thon is scheduled for October 22, 2011 at 9:00 am in Festival Park and to date over \$226,000 had been raised for the cause, which is twice the amount raised last year.

E. Public Hearing on a Resolution of Intent to Close Unnamed Right-of-Way Off of Cypress Lake Circle (SR 2307) as Recorded in Plat Book 118, Page 99 in the Cumberland County Registry

BACKGROUND:

Mr. & Mrs. Michael Kidd, Mr. & Mrs. Marion S. Faircloth Jr. and Mr. George F. Norton III, all adjacent property owners to an unnamed right of way off Cypress Lake Circle (SR2307) as recorded in Plat Book 118, Page 99 in the Cumberland County Registry, in Grays Creek Township have petitioned that the unnamed right of way be closed. The Board has called a public hearing to consider its request. The Board may close the road if it finds that no person will be denied reasonable egress or ingress to his/her property.

RECOMMENDATION AND PROPOSED ACTION:

If the Board of Commissioners makes the required statutory finding and decides to close the unnamed right of way off Cypress Lake Circle, that the Board adopt the resolution closing of an unnamed right-of-way off Cypress Lake Circle and direct the staff to record it in the Cumberland County Registry.

RESOLUTION CLOSING OF AN UNNAMED RIGHT-OF-WAY OFF CYPRESS LAKE CIRCLE

WHEREAS, a petition has been submitted to the Cumberland County Board of Commissioners (the "Board") by all adjoining landowner to close an unnamed right-ofway off Cypress Lake Cir, in Cumberland County;

WHEREAS, following proper notice, the Board held a public hearing on the question of the closing of such right-of-way on the 17th day of October, 2011, and heard all interested persons who appeared with respect to whether the closing would be detrimental to the public interest or to any individual's property rights; and

WHEREAS, following the public hearing the said Board found and determined that such public right-of-way is not under the control of the North Carolina Department of Transportation; that no person would be deprived of reasonable means of ingress and egress to his property by such closing, but that the reservation of certain easements would be appropriate and desirable; and that it is therefore not contrary to the public interest to close such street, subject to the reservation of the easements described below;

NOW THEREFORE, the Cumberland County Board of Commissioners hereby RESOLVES, pursuant to authority granted by G.S. 153A-241, that the public street more particularly described below be, and it is hereby, closed, subject, however to the continued dedication and preservation of an easement therein for existing and future utilities, and of an easement therein for public safety emergency vehicle access:

And the Board further RESOLVES, that a certified copy of this Resolution be recorded in the Cumberland County Registry.

Rick Moorefield, County Attorney, referenced the tax map of the area labeled Exhibit B and stated the cul-de-sac is the unnamed right-of-way and all three owners signed a petition requesting that it be closed.

This is the duly advertised public hearing set for this date and time. Chairman Edge opened the public hearing. The Clerk to the Board called the following speaker:

James A. McLean – Mr. McLean appeared in favor and stated he was present on behalf of the petitioners in the event there were questions or concerns. Mr. McLean further stated the petition is to close a cul-de-sac that was never built.

There being no further speakers, Chairman Edge closed the public hearing.

- MOTION: Commissioner Council moved to adopt the resolution closing an unnamed right-of-way off Cypress Lake Circle and direct the staff to record it in the Cumberland County Registry SECOND: Commissioner Melvin
- VOTE: UNANIMOUS (7-0)

F. Public Hearing on the Board of Commissioners Redistricting Plan

BACKGROUND:

At its last meeting, the Board voted to approve the Alternative A Redistricting Plan, subject to receiving public comment on the plan at the October 17, 2011, evening meeting. Notice of the public hearing was advertised in the Fayetteville Observer during the week of October 10th.

Alternative A changes the district boundaries as follows: The currently split precincts of Westarea 1 and Cross Creek 9, 2, 28-1 and 28-2 will be completely shifted to District 1; the currently split precincts of Cross Creek 22 and 23, Eastover 1, Judson-Vander and Auman 1 will be completely shifted to District 2; and the precincts of Cross Creek 25 and 27, Montibello, and Cliffdale West 1 will be shifted from District 2 to District 1.

RECOMMENDATION/PROPOSED ACTION:

After considering any comments received at the public hearing, adopt the following resolution to create the boundaries of the new commissioner districts:

BOARD OF COMMISSIONERS OF CUMBERLAND COUNTY RESOLUTION TO REDISTRICT THE COUNTY COMMISSIONER ELECTION DISTRICTS IN CUMBERLAND COUNTY

Whereas, this Board finds that after the 2010 census, there exists a deviation of 31.68% from the ideal population in the county commissioner election districts within Cumberland County; and

Whereas, this Board finds that it is necessary to redistrict the county commissioner election districts to reduce this deviation to not more than 10%; and

Whereas, this Board has expressed its goal to minimize the number of voting precincts split between the two county commissioner districts because this Board finds that this will avoid confusion to voters living within these precincts; and

Whereas, this Board has expressed its goal to maintain the relative percentages of African-American to white and other minority voters within Commissioner District 1 as close as possible to the ratio in existence before the 2010 census because this Board finds that this has enhanced the opportunities for African-American candidates for county commissioner to be elected; and

Whereas, this Board has considered no less than five proposed redistricting alternatives which were consistent with its goals and has advertised and held a public hearing to receive public comment on its intended redistricting plan; and

Whereas, this Board finds that the redistricting plan stated below produces a nearperfect population distribution between the two commissioner election districts; eliminates all split precincts; and maintains the relative percentages of African-American to white and other minority voters within Commissioner District 1 as is possible. Now therefore be it resolved that the Cumberland County commissioner election districts shall be reconstituted and redistricted as follows:

1. The currently split precincts of Westarea 1 and Cross Creek 9, 2, 28-1 and 28-2 shall be completely shifted to Commissioner District 1.

2. The currently split precincts of Cross Creek 22 and 23, Eastover 1, Judson-Vander and Auman 1 shall be completely shifted to Commissioner District 2.

3. The precincts of Cross Creek 25 and 27, Montibello, and Cliffdale West 1 shall be shifted from Commissioner District 2 to Commissioner District 1.

3. All other precincts shall be unchanged.

Mr. Moorefield reviewed the background information as indicated above and referenced maps indicating Alternative A changes to the district boundaries. Mr. Moorefield stated the districts have to be described with specificity and the identification of the affected precincts is described in the resolution.

This is the duly advertised public hearing set for this date and time. Chairman Edge opened the public hearing.

The Clerk to the Board advised there were no speakers.

Chairman Edge closed the public hearing.

Commissioner King asked about the percentage make up of the new district as presented. Mr. Moorefield advised it is roughly within about two tenths of one percent of what it was before for each class of voters, minority and non-minority.

MOTION: Commissioner Council moved to adopt the resolution to create the boundaries of the new commissioner districts.

- SECOND: Commissioner Melvin
- DISCUSSION: Commissioner King stated the shift in population means that the county and the City of Fayetteville are going to have to take a serious look at developments within the community in the future. Commissioner King further stated there is a decline in population within a particular area and there will be further discussion about it in the future.

Commissioner Faircloth stated it also highlights the fact that you can not pin minorities down to a particular area because they reside county-wide and it will become more and more difficult as people find housing opportunities all over the county to come up with districts like this. Mr. Faircloth stated the county will face challenges in the future as it pertains to making up districts that are representative.

Mr. Moorefield clarified that both districts have grown in population; it is just that District 1 is growing at a much slower rate than the rest of the county. Commissioner King stated there is a shifting and an aging of the population in District 1 which indicates a need to enlarge the area to bring in additional bodies. Commissioner King stated this will involve discussion at the city and county level in terms of how the community grows.

VOTE: PASSED (6-1) (Commissioners King, Faircloth, Edge, Council, Melvin and Keefe voted in favor; Commissioner Evans voted in opposition)

ITEMS OF BUSINESS

6. Approval of Renewal of Courthouse Deli and DSS Snack Shop Franchise Agreement (1st Reading)

BACKGROUND:

Shana B. Yi and Jae Yong Yi have operated the DSS Snack Bar since September 23, 2008, and the Courthouse Snack Bar since September 29, 2003, under successive franchises granted by the Board of Commissioners. They wish to renew the franchises which expired September 30, 2011, on the same terms. The franchisee pays the County Six Percent (6%) of the net sales generated by the Snack Bars ("the Commission") with a minimum Commission of \$500.00 per month for each of the snack bars. The term "net sales" is defined as the gross receipts of the Snack Bars less sales tax and discounts. The amount of the average commissions paid each year is attached.

Because this is a franchise agreement, it will have to be approved at two meetings of the Board.

RECOMMENDATION/PROPOSED ACTION:

Approve the franchise agreement on first reading and direct Clerk to place it on next agenda for second reading.

Mr. Moorefield reviewed the background information as indicated above and stated the snack bars have both received good reviews. Mr. Moorefield stated the 2011 average monthly revenue for the courthouse deli was \$528.03 and \$500.00 for the DSS deli.

MOTION: Commissioner Council moved to approve the franchise agreement on first reading and direct the clerk to place it on the next agenda for a second reading.
SECOND: Commissioner Faircloth
VOTE: UNANIMOUS (7-0)

7. Nominations to Boards and Committees

A. Civic Center Commission (1 Vacancy)

BACKGROUND: The Civic Center Commission currently has one (1) vacancy due to a resignation. Robert Smith – resigned. Recommendation of the Civic Center Commission is for Peter Best, Dr. Mary A. Hales, Warren G. McDonald, or John Hood.

Chairman Edge nominated John Hood. Commissioner Evans nominated Barbara Spigner. Commissioner Keefe nominated Kirk Deviere.

B. Cumberland County Local Emergency Planning Committee (1 Vacancy)

BACKGROUND: The Cumberland County Local Emergency Planning Committee currently has one (1) vacancy for an unexpired term. Emergency Management Representative Greg Phillips – retired. Recommendation is for Gene Booth.

Commissioner King nominated Gene Booth.

C. Human Relations Commission (1 Vacancy)
